Position: Co-chair for the International Development Coordinating Group (IDCG)

The International Development Coordinating Group (IDCG) is a multidisciplinary network of researchers, policymakers, practitioners, and funders committed to evidence-informed policies. This network is part of the Campbell Collaboration, and 3ie provides technical expertise and editorial services to authors of systematic reviews that focus on international development.

The new Co-chair of the International Development Coordinating Group (IDCG) will participate in regular meetings which they will manage jointly with the incumbent Co-chair, Marie Gaarder. To learn more about the work of the group, visit the IDCG section of the Campbell website.

Description of roles and responsibilities

The IDCG co-chairs' roles and responsibilities are aligned with those of all Campbell Groups' co-chairs, and require to be:

- (a) Responsible for internal governance of the CG (make sure key roles are filled and others are doing their jobs);
- (b) Establish and maintain collaborative working relationships with other organizations and Campbell entities;
- (c) Disseminate information about the CG and Campbell;
- (d) Receive all criticisms related to activities of members of the CG:
- (e) Make final decisions for the CG regarding policy and implementation;
- (f) Recruit volunteers for CG activities and functions;
- (g) Convene CG meetings;
- (h) Responsible for ensuring the quality of content on the CG's Campbell webpages;
- (i) Serving as representatives to the Campbell members' conference or designating such representatives to serve in their place.





Additionally, the CG Co-Chairs will have the following duties:

- (a) Recruiting volunteers to perform the editorial functions associated with producing reviews.
- (b) Maintaining processes and procedures to ensure the quality of protocols and reviews; (c) Ensuring that approved protocols and reviews are transmitted in a timely fashion to the Editor in Chief for their decision about publication.

Interested individuals from the Global South are strongly encouraged to apply.

- A cover letter highlighting your qualifications and experience relevant to the terms of reference, including but not limited to leadership experience, contributions to evidence-based policy, or network-building skills and how you plan to make an impact on international development research
